It is essential for you to follow the instructions below for your application to be considered.

1. This application is to be accompanied by **Three Copies** of a location plan (**scale 1:2500**) indicating the location of the proposed works.
2. This application is to be accompanied by **Three Copies** of all sectional plans to a scale of not less than **1.500** to clearly indicate the nature of the proposed works.
3. The information supplied shall indicate:-
  - The size, type and gradient of any pipes or culverts
  - The levels of such pipes/culverts
  - The direction of flow
  - The methods and materials used for backfilling
  - The positions and details of any manholes to be used
  - Also, if applicable, details of the area to be drained with the number and size of outfalls into the proposed pipe or culvert
  -
4. This application does not obviate any powers of the Internal Drainage Boards under their Byelaws and Section 23 of the Land Drainage Act 1991. Therefore applicants are advised that their proposals will be referred to the relevant Internal Drainage Board for consideration.
5. If the ditch is located by a road, it is advisable that the applicant contacts Norfolk County Council – Highways Division, to see how their proposals may be affected by highways drainage.
6. Any acceptance of this application is not an endorsement for works carried out on another owner's property. It is advised that the applicant obtains approval for the proposed works from the owner(s) of the dyke and adjacent land owner(s) before proceeding with the application.
